A non- resident fee will apply to the deceased if he/she has resided outside of the London Borough of Southwark for a period longer than 5 years or more, at the time of their demise.

All grave types offered are subject to availability. Only Southwark paperwork will be accepted and coffin sizes must be provided in writing.
